Studying at Lazarski University is considered to be one of the best in the country, and the Law in Business course has been prepared with the problems and challenges facing the modern entrepreneur in mind.

In 2023. Faculty of Law and Administration ranked first for the 15th time in the 16-year history of the ranking of law faculties of non-public universities of "Dziennik Gazeta Prawna", and the scientific category A+, awarded by decision no. 242/507/2022-1, confirmed the faculty's very high position in the higher education system. Already in 2006. The University was authorised to confer the degree of Doctor of Laws in the discipline of law. Since 2016, it has been authorised to confer the degree of Doctor of Juridical Sciences in the discipline of law.

An important priority is the popularisation of science through the WPiA quarterly lus Novum (100 points) published at the University and the WPiA semi-annual Veritas Iuris (which provides a forum for the exchange of views for students, doctoral students and graduates of law faculties).

Programme description

The specialisation 'Administration in the Economy' ensures that you are provided with the knowledge, skills and competences in the subject matter necessary to better conduct business. It is aimed at candidates who are interested in the economy and the administration sector, who want to learn about the structure and functioning of public administration in order to better understand its impact on the economy. This interdisciplinary specialisation combines theoretical knowledge of administration with practical skills in its application. It is tailored to meet contemporary labour market requirements from the economic sector. It provides an opportunity for professional development and allows you to understand the complex administrative processes taking place in the economy.
